Remote Learning Commitment Form

Parents may request that their student(s) attend remote learning by completing this form. Deadline for submission is Tuesday, August 4th, 2020 at 5:00 p.m. If the deadline has passed, please contact Meriwether Board of Education at (706) 441-0601 or your student(s) school. If you have any questions or need assistance with this process, please call your student(s) school.

Remote Learning Agreement:

Students in remote learning classes are expected to make weekly progress and attend class on a daily basis. Students will complete the course requirements independently within designated timelines. Because of the nature of a remote learning course, it is important that the teacher, student, and parents agree to commit the time and energy needed to successfully complete the course. In order to earn credit and/or a passing grade for the course, students must meet a set minimum criteria as established by the teacher. Enrollment in remote learning is for a nine-week period at the elementary and middle school levels and for a semester at the high school level.

Student Expectations:

Ethics: Remote learning students are expected to complete their own work at all times, and complete assignments according to class guidelines. If a student breaks this code of ethics, the student will not receive credit for the assignment, assessment, or course. A student must also read, sign, and follow the Acceptable Use Policy (AUP) available in the Student Handbook regarding technology and the Internet.

Communication: Students must log into Google Classroom and check messages daily for updates from their teacher. It is the student's responsibility to contact the teacher if he/she experiences difficulties in completing the coursework. Parents/guardians should also be in frequent contact with the teacher and inform the teacher of any concerns with the course or learning problems that arise.

Attendance: In order to be counted present for each class, remote learning students are required to:

- Attend all live learning activities.
- Log into Google Classroom each day.
- 3. Participate in each course daily. This means actively engaged in course activities including viewing content and completing assignments and assessments.
- 4. Communicate regularly with the teacher.

A student will be counted present when they have logged-in that day, engaged in the course content for that day, and has made adequate progress on the assigned activities. Students may be asked to attend mandatory meetings and/or attend one-on-one conferences with the teacher. These meetings may be inperson or virtual. These requirements may be for orientation, pupil accountability, and/or for proctored exams. In the event a student is unable to access Internet, a specialized remote learning plan will be developed for your student(s). Please contact the school in the event there are issues with Internet accessibility.

Elementary/Middle Expectations:

Parents who register students for the remote learning option will receive core (English Language Arts [ELA], Math, Science, and Social Studies) instruction through Google Classroom. Students will also be offered specials instruction in the areas of art. music. and physical education throughout the week. Specials

instruction may be facilitated by the instructor or by your child's remote learning teacher with guidance from the specials teacher. Teachers will post relevant materials to support students such as annotated notes, visual presentations, videos, and independent practice assignments. Students should login each day to check for assignments and instructions from the teacher. Teachers also have the option to utilize video/phone conferencing for live lessons. Live lessons will require registration for a morning or afternoon session. Students must attend all live sessions. Adult supervision is required for elementary students to participate in remote learning. Academic supports for students with disabilities, 504 plans, and English Language Learners will take place virtually in collaboration with content teachers. Additional information regarding remote learning will be forthcoming.

High School Expectations:

Parents who register students for the remote learning option will be able to take core (ELA, Math, Science, and Social Studies) instruction through Google Classroom and a combination of other appropriate platforms such as Odysseyware, Study Island, Exact Path, and USA Test Prep. Courses will not be simply completing an Odysseyware class. The course will also include assignments through Google Classroom and other appropriate sources. Teachers may post relevant materials to support students such as annotated notes, visual presentations, videos, and independent practice assignments. Students should login each day to check for assignments and instructions from the teacher. Teachers also have the option to utilize video/phone conferencing for live lessons. Students must attend all live sessions. Academic supports for students with disabilities, 504 plans, and English Language Learners will take place virtually in collaboration with content teachers. Students in remote learning courses will be required to take a final exam that will count 20% of their final grade. This final exam will be monitored per the high school administration's directive. Additional information regarding remote learning will be forthcoming.

Parent/Guardian: I acknowledge that ADULT SUPERVISION is required for elementary students and recommended for middle school and high schools students to participate in the remote learning class. I agree to help my student(s) with their work in order to be successful in all remote learning courses. I am aware there will be attendance requirements for my student(s), as well as daily work requirements and assignment due dates. I understand if my student(s) does not meet the above stated criteria, he/she may be in jeopardy of receiving a failing grade and/or will not receive credit for the course.
